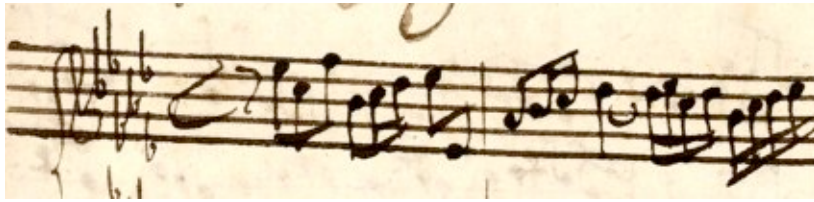

Yes, we have cancelled our 2020 October concert/dinner/fundraiser. We think it is prudent to just wait before taking the time and energy and money to plan big events until our State Government decides that large crowds are permitted to congregate without danger of transmitting Covid 19 to others. Please wear your mask when you go out shopping. I always wear mine when I go to the supermarket, or post office, or any public indoor space.

My son-in-law caught Covid 19. He's a doctor. Despite taking all precautions, he caught it. He's in his mid-thirties. He first noticed the symptoms on a Sunday in June. On Monday he went to get tested. On Tuesday he got the results. Then for two weeks he stayed in lockdown in the guest room of their house, and my daughter dropped off his meals at the door. He kept close watch on his blood oxygen levels, and they were fine, so he didn't need to be admitted to a hospital. However, he was miserable for about two weeks, with some very, very unpleasant symptoms. He returned to work after two weeks. Lucky for them.
